IAF Database of Accredited Certificates

The 2017 IAF General Assembly approved the establishment of a database of management system certificates provided by certification bodies accredited by IAF members.

The database presents a unique opportunity for organisations with accredited certificates to be able to have their certificates in the database, presenting to the outside world the fact that they are certified to some of the world's leading standards such as ISO 9001 and ISO 14001.

IAF Chair Xiao Jianhua said, "I am delighted IAF is developing the database. This adds value for the certification bodies accredited by IAF members but most importantly for the organisations that hold over 1.6 million accredited management system certificates. The benefits extend even further, for example to buyers wishing to check if their potential suppliers hold such certificates".

Xiao continues, "IAF will continue to work with its accreditation body and certification body association members, and very significantly, its users on this exciting development."

A related video has been posted in the IAF/ILAC YouTube channel.

Further updates on development of the database will be provided during the Singapore meetings.

IAF is celebrating its 25th anniversary!

IAF was first formed in Houston, USA on 28 January 1993. It was established with the aim of facilitating international trade by developing equivalent accreditation systems for conformity assessment so that products, processes, and services certified in one region or economy could be accepted in others.

SIGNIFICANT MILESTONES SINCE THAT TIME...

- In 1995 IAF became a fully operational organization when the IAF Memorandum of Understanding was signed by 9 Accreditation Bodies in Geneva, Switzerland.

- The first IAF Multilateral Recognition Arrangement, for Quality Management System Certification, became operational on 22 January 1998 when 13 Accreditation Body Members signed the Arrangement during the 11th IAF Plenary meeting in Guangzhou, China.

- IAF was legally incorporated on 27 September 1998 in the State of Delaware, USA

- In 2001 IAF and the International Laboratory Accreditation Cooperation (ILAC) began formalising their cooperation by holding their first combined General Assembly in Kyoto, Japan.

- The IAF Multilateral Recognition Arrangements for Environmental Management System Certification and Product Certification became operational on 9 October 2004 at the 18th IAF Annual Meeting held in Cape Town, South Africa.

- The current structure of the IAF MLA, i.e. one MLA based on ISO/IEC 17011 with Main Scopes and Sub-Scopes, came into effect on 22 December 2009.

- A new procedure for processing IAF MLA Sub-Scope extensions in a more efficient manner was launched on 05 April 2018.

The number of IAF Members now totals 107, with 81 Accreditation Body Members, 20 Association Members, and 6 Regional Accreditation Group Members.

The IAF MLA now has 68 Accreditation Body signatories and 5 Recognized Regional Accreditation Groups with 4 main scopes and 9 sub-scopes.

As IAF celebrates 25 years of growth and success, IAF is also looking forward to continuing to develop and support trade, regulators and the health and environment in the general community through accreditation, with goals such as launching the IAF Database of Accredited Management System Certifications.

Did you know?

UPDATE ON THE BUSINESS BENEFITS WEBSITE

Standards, certification, testing, inspection, metrology and accreditation (collectively known as the Quality Infrastructure) help businesses of all sizes and sectors to reduce costs, limit their environmental impact, improve quality, access new market opportunities, and differentiate themselves from competitors.

To illustrate the value of the Quality Infrastructure and the services its organisations provide, this site includes case studies, research papers, and supporting materials that confirm these benefits for the business community. The examples published on the website cite tangible financial data to evidence the cost savings achieved whether through resource efficiency or meeting regulation at lower cost, the value of accessing new markets, or savings achieved through recognition from organisations such as insurers, regulators or purchasers.

The site has been developed by the organisations that make up the Quality Infrastructure including global standards bodies, global accreditation associations, and trade associations from the certification and conformity assessment industry. End-users are invited to submit examples that provide financial or performance data for consideration.

2018 Joint General Assembly

This year's Joint General Assembly (JGA) will take place on 30 October, 2018 from 08:30 to 17:00 in the Grand Salon at the Singapore Grand Hyatt.

The signing ceremony for new members to IAF, and signatories to the IAF MLA and ILAC MRA will be held as part of the IAF/ILAC JGA in Singapore.

This provides an excellent opportunity to acknowledge the work of the accreditation bodies signing the IAF MLA and ILAC MRA and those extending their recognition to these Arrangements. There will be accreditation bodies from all regions of the world involved in this signing ceremony, as well as including the recognition of the AFRAC MLA to the IAF MLA and ILAC MRA as was agreed earlier this year in May.

AFRAC is one of the main pillars of the Pan African Quality Infrastructure system in supporting intra-African trade, improving the competitiveness of African goods and services in the global market and facilitating health and safety of the public and the environment.

The JGA will also receive reports from a number of other international organizations with whom IAF and ILAC have Memoranda of Understanding with, or are partnering with, including the International Organization for Standardization (ISO), the International Electro-technical Commission (IEC), the United Nations International Development Organization (UNIDO), the International Telecommunications Union (ITU), Organisation Internationale de Métrologie Légale (OIML), the World Trade Organization (WTO), and the World Bank.
