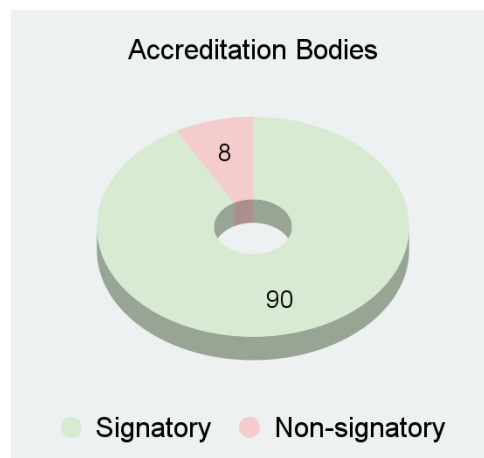
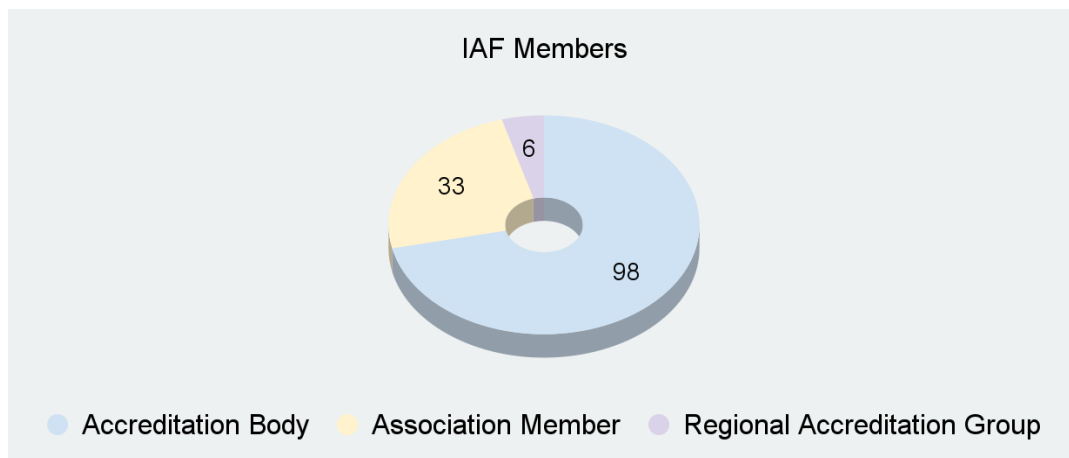

For decisions associated with MLA signatories, only the MLA Signatory Accreditation Bodies (listed in Table) 1 are entitled to vote. For all other MLA related matters all Accreditation Bodies and Association Members (listed in Tables 1, 3 and 5) can vote. Regional Accreditation Groups have no voting rights.



IAF MLA Scopes

Currently there are five main scopes for the IAF MLA: Management Systems Certification, Product Certification, Certification of Persons, Greenhouse Gas Validation and Verification, and Validation and Verification.

A main scope means certificates are 'equally reliable' because the conformity assessment bodies conform to the same standard. The combination of a Level 2 activity and the Level 3 relevant normative document is called a main scope of the MLA.

A sub-scope means the certificates are 'equivalent' because the management systems, products, services or persons conform to the same standard.

Sub-scopes are divided into two categories (Level 4 and Level 5), as described in section 2 of IAF PL3 - Policies and Procedures on the IAF MLA Structure and for Expansion of the Scope of the IAF MLA.

- MLA Level 1 – ISO/IEC 17011, specifies the criteria for accreditation bodies
- MLA Level 2 – Accreditation activities
- MLA Level 3 – IAF-endorsed generic normative documents used by accreditation bodies
- MLA Level 4 – IAF-endorsed sector-specific normative documents used by accreditation bodies
- MLA Level 5 – IAF-endorsed normative documents used by conformity assessment bodies
